 - iv. Drone usage and illegal raves are to be clamped down on.

 - i. The meeting was very useful as the Borough Councillors and Officers present listened to what the Parish Councillors had to say.
 - ii. A loan at a rate of 4.5% is available to Parishes from the Borough Council to pay for the street lights to be changed to LED lighting. The street lights are being considered to be given to the Parishes.
 - iii. Various planning issues were voiced by the Parish representatives.
